Dear Families,

As per Governor Walz's order today, April 23, 2020, we will continue our distance learning plans for the remainder of the school year. Per the Governor's order, we will be using Friday, May 1 and Monday, May 4 as preparation days for our staff. There will be no distance learning on these two days.

Included within this order, we will continue to offer free meals to children ages 1-18 and emergency child care for those families that are eligible through Friday, June 5. Please see more detailed information below regarding these services.

### **Distance Learning**

Distance Learning will continue to provide Early Childhood - Grade 12 students with access to appropriate educational materials and ensure they receive daily interaction with their licensed teacher(s). ### Meal Distribution Plan

### Child care

We will continue to offer childcare for students ages Kindergarten through age 12 for parents who are emergency and essential workers that are required to report to work per Governor Walz's Executive Order. The District will continue to provide school-day care free of charge; however, a change for all families is a charge for before and after school care. Fees will be \$4 for morning care and \$6 for after school care. Families who have been utilizing the emergency child care site will receive direct communication from the SAC Team with official notice of the change and guidelines for continuing to access Emergency Child Care.

Additionally, child care opportunities will be extended to ALL families for a fee of \$30 per day. Application for care can be completed at <u>school district/community education website</u>. An FAQ sheet is available on the school district/community education website to answer questions, provide contact information and further directions to enroll in child care for the remainder of the school year. # Care contracts will be accepted on a first come, first serve basis until site capacity is reached. A site capacity has been established that allows for continuing physical distancing and full utilization of available staff.
